**Let's begin by defining what "scoping" is so that you can see the Big Picture. Scoping is the process of editing legal transcripts (depositions, hearings, trials, and the like) for court reporters. Those who scope are known as scopists, and they work as independent contractors. Basically, what you need besides a burning desire to work from home is a computer, transcriber, Internet connection (preferably broadband), computer-aided transcription (CAT) software, reference books...and scoping training. Enter Judy Rakocinski and Cathy Vickio, who founded BeST Scoping Techniques on March 1, 2002!**

We sometimes hear from people who are worried about the future of court reporting (and thus scoping) with the advance of "electronic" courtrooms and voice-recognition software, but none of these can produce a written transcript without a human involved. With the proper professional training, a scopist will continue to be a vital part of the process reporters rely on to keep their production high and turn out accurate verbatim transcripts.**
